- Recipients must be and remain members in good standing and in good social standing, as determined by CEFCU.
- Preference is given to students with demonstrated financial need (scholarship not solely based on financial need).
- The scholarships will be available to all students regardless of age, race, sex, or undergraduate program of study. The scholarship will not be
 available to CEFCU employees, current/former CEFCU officers and director/volunteers, or "immediate family members" of current/former
 CEFCU officers and director/volunteers. Immediate family members are defined as related by blood or marriage to a parent, spouse, child,
 sibling, or grandparent.
- Applicants must not have previously received a CEFCU Member Appreciation Scholarship.
