- 1. Complete this form and accompany it with a *typewritten letter* of appeal. The letter should contain *all* pertinent facts and supporting evidence. It should also address three specific issues.
 - A. Provide an explanation for your inadequate grade point average.
 - B. Give a plan of action for future academic success or degree completion.
 - C. Outline the college and courses that you have taken or work you have done since leaving Bradley.
- 2. Send the accompanying Associate Dean's Review form to the Dean's Office of your College (or new College if you are intending to change majors) and meet with that person to discuss your plan of action.
